This Special Meeting was called to meet the deadlines of the state's Local Election Districts Review Committee. Wendy Stevens, Town Clerk, explained the updated plans and requested the Board rescind their vote taken on October 18, 2021 and re-vote the updated Re-Precincting Plan presented to them this morning. She said the new description has been reviewed by her and the Secretary of State for approval.

Ward moved the Board of Selectmen rescind the vote taken on October 18, 2021 pertaining to the Board's acceptance of the presented 2020 Re-Precincting Plan for the Town of Winchendon and move to accept the map, block data report and legal description presented this morning by Town Clerk, Wendy Stevens, for the 2020 Re-Precincting Plan for the Town of Winchendon; seconded by LaPointe. With a roll call vote of all aye, the motion carried unanimously.
