**Project Description:** Removal of a  $4' \times 11'$  covered deck followed by replacement in the same footprint with an addition on a block foundation. Also, construction of a  $12' \times 12'$  (144 sq. ft.) deck and staircase.

The deck is being placed on the existing lawn and is 50' from the wetlands. The plans were submitted to the building department but Mr. Zwahlen did not have them on hand at the meeting so the commission was unsure of a decision.

**Project Description:** Construction, operation, and maintenance of a 3.135 megawatt direct current ground-mounted solar photovoltaic system, including access road, perimeter fence, stormwater

management infrastructure, grading, and landscaping.

Andrew Vardakis, engineer and project manager with WOOD, and Bill Behling, director of business development with Sunpin solar introduced themselves. Since the last meeting, a new design was created to remove the panels around the permitter of the 50' buffer zone and pushed back to the 75' buffer. Those panels were moved to the small isolated wetlands area in the center of the project, and a replicated 2:1 scale wetlands was created to compensate. They addressed Tighe & Bond's comments and submitted the new plans to them to review. Tighe & Bond's peer review was not completed yet so the commission decided to continue the hearing to the next meeting.

Kyle Bradley joined the meeting.

Kyle Bradley made a motion to continue to hearing to February 13th at 6:00PM, 2nd by Tony George. **VOTE-** Unanimously approved.
