**TRANSFER REQUESTS:** A motion was made by Ulysse Maillet to transfer \$1,000 from Police Differential, \$1,500 from Education Incentive and \$2,000 from Police overtime all to be transferred to Dispatch Overtime Account. The motion was seconded by Robert Guenther.

The Finance Committee discussed taking action on disputed warrant articles number 5 and 6. Chairman Kane said the DOR suggested taking out of stabilization. Chairman Kane informed the committee that the School Committee agreed to pass over article 11. He said that since there is no overlay surplus then articles 4, 5 and 6 will need to have money to cover them. Christian said that it is not a good way to budget.

A motion to support Articles 4, 5 and 6 and take the money out of stabilization was made by Ulysse Maillet. The motion was seconded by Robert Guenther. Christian said that we should pass over these and find the money later. He said we will know more about stabilization in the fall. Chairman Kane said that there will be 1.2 million in stabilization. He said the town used some of stabilization for cash flow. The motion was defeated.

A motion was made by Ulysse Maillet to approve Article 4 and take it out of stabilization. The motion was seconded by Robert Guenther. The motion was defeated
