- 4. Correspondence and Announcements: The committee members are invited to A Meet and Greet hosted by the Greater Gardner Chamber of Commerce.   - J. Corbosiero moved to take Teaching and Learning Highlights (agenda item #7) out of order and have it now. Second by L. Murphy. Approved 5-0-0.
- 7. Teaching and Learning Highlights: Jamie Hobbs

Suzanne Michel, Assistant Director of Student Services, introduced Jamie Hobbs, the A. L. L. Program Teacher at the Memorial School. This program serves grades Pre-K through Grade 2. Noting that Autism severely impacts the area of communication, Ms. Hobbs showed how the students are taught communication, social and adaptive skills with the teacher, para-professionals and other students in the program. She showed a video of the students showing or telling what they do in class, pointing out successes and difficulties they encounter. The educators also generalize the learning to use outside of the classroom and eventually in the workplace. F. Nurmsen stated that technology is the great equalizer as long as the student has that support system in school, adding companies are hiring people with or on the autism spectrum. L. Murphy-reported that Ms. Hobbs' students put the weekend food backpacks together; they created a system that works very well. He added the students communicate with him without being prompted.

Blue Devil Cool Award: Jamie Hobbs, ALL Program Room Teacher. S. Haddad noted she is a news teacher in the system and is a true inspiration. Her support of her students has excelled far beyond what would be expected. S. Haddad listed her and the student's accomplishments, noting positivity and great communication with parents and guardians. F. Nurmsen commended the high level of expectation the students will rise to.

## 10. New Business:

a. Field Trip - Middle School 7<sup>th</sup> Grade Field Trip- Calvin Miller, teacher, noted the 8<sup>th</sup> Grade Field Trip is on Friday, June 9<sup>th</sup>. The students will tour parts of Boston and go to the Red Sox vs. the Detroit Tigers baseball game. S. Haddad reviewed the 4<sup>th</sup> annual trip to the YMCA Camp Takodah in Richmond, NH from May 22-25, an outdoor education experience. S. Haddad explained the qualification process, the students fundraising efforts and the educational benefits. The school committee was invited to the Annual Parent and Guardian picnic on May 24<sup>th</sup>. J. Corbosiero moved to approve the trip to Camp Takodah. Second by D. Fronte. Approved 5-0-0.

## 7. Superintendent Report:

About 60 people came to the Opiod Abuse Awareness Forum sponsored by District Attorney Joe Early. It was very positive. Town Officials, Representative Zlotnik and Senator Gobi attended. He reviewed the speaker's stories, adding it was heart wrenching and insightful. The DA said this was one of the best forums he has attended.

The Town Meeting is on May 15<sup>th</sup> at 7:00 PM; there will be babysitting. He asked voters to approve Article 16. He explained the relationship between NSS and Educational Outcomes. Districts who receive additional funding are able to achieve better academic outcomes, and to reach Level 1; there is a direct correlation the higher above NSS district is. Winchendon falls into the 0%-1% above NSS and is at Level 3; other districts receiving that level of funding are Level 3, 4, or 5. Winchendon is at 1% due to the override in 2013. However, the district has to give \$236,000 back to the state toward the town's debt. Thus, it only has access to \$87,000. He stated 'We cannot prepare our students for life without the override' of \$417,675 to keep our schools moving in a positive direction. F. Nurmsen suggested the district pursue revenue sharing with the town as recommended by the Department of Revenue to gain additional funding. She also said the town needs to prioritize what it needs, adding that when the town does well the schools should do well too; it should be reflected in the entire community. She believes the children's' education is more important than the Sally Port and the new fire truck proposed.

S. Haddad talked about the Plans, noting the administration will look at the action items every week. There will be a presentation at the end of the school year. A survey of students who choice-out will be presented by June, including a breakdown of what schools they choose to attend. F. Nurmsen noted they are not leaving to attend Level 1 schools and suggested the district 'may be missing the mark with the families' since academics do not seem to be the issue. S. Haddad explained the 'Wall of Fame' he plans to introduce at the Alumni Banquet.
