#### **Unfinished Business:**

60 Franklin Street: Mr. White has had contact with North Central Mass Development Corp. They are interested in selling the property to Gary Bator. Negotiations are in progress. Subject to WRA mortgage, taxes, and sewer betterment. WRA will take under advisement. There is concern about Mr. Bator having another mortgage with the Authority as he is not up to date with his payments for 50 Franklin Street.

Phase V Bike Path: Mr. White has been contact with Vicky Marsh of Kopleman and Paige. Paperwork should arrive by 3-14-2014 and closing should be mid April 2014. DOT still has some issues with Tighe & Bond. Dave Loring is handling on Tighe and Bond's end. Mr. White stated Tracy Wu of DOT is especially difficult to work with. Mr. White has had to

send information repeatedly to discredit her issues. Trying to secure funding for sprinf construction.

Wind Tower: Mr. White has received a small response from his email. Project Review Committee is next step.

Front Street Landscaping: Work will resume in the spring.

Mylec Road Design: Mr. Hannigan did respond to Mr. White. John Deline will review road for Town accdeptance. Mass Works may have available funding for road completion. Mr. White to check into grant possibilities. There is no funding through the previous EDF Grant through DHCD.

Ahimsa Haven: No new information for this meeting.

Tannery Hill Property: The legal work is almost complete. Working through trust issues. Probate is forthcoming. Mr. White to have more information available shortly.

Winchendon Loop Parks: Project is on hold pending the decision of Robinson Broadhurst Steering Committee. Decision on project should be made shortly and Mr. White will proceed accordingly.

Steering Committee Update: Tracy Murphy is working om maps for the project. The next scheduled meeting is 4-6-2014. Ms. Murphy should be completed with maps by early next week.

Town Hall Garage: Meeting is scheduled with Cumberland Farms on 3-10-2014. Mr. White has spoken with Corey Bohan, president of the Historical Commission for ideas and to listen to his concerns. There may be a way of incorporation Joseph's counter fountain in the new Cumberlands.
