7. NEW BUSINESS:

7.1. 7.2. Winchendon Unaccepted Roads Orders of Taking-Follow Up from December 2023 Special Town Meeting- Bill McKinney, Town Manager said this is a follow up, the town voted to accept these unaccepted roads. The order of takings need to be recorded with the registry by tomorrow. **Selectwoman LaPointe moved that the Board Selectman vote to approve and execute the Orders of taking for the following roads, as accepted at the December 11, 2023 Special Town Meeting: Hillside Drive, Jefferson Avenue, Shady Glen Terrace, Summer Drive, Wendell Drive, Maple Place B, Phyllis Road and Chase Lane in Sandy Heights, Blue Bird Road and Loon Road in Benjamin Hill Estates, Converse Drive, Prentice Circle, King Phillip Way, and Hapgood Road in Winchendon. Selectwoman Blanchard seconded. Roll Call Vote: LaBrie aye, LaPointe aye, Blanchard aye, and Ward aye.**

7.3. Commission on Disabilities Presentation-Miranda Jennings, COA Director, Kristina Seavers, and Susan Kuchta came forward. Ms. Kuchta said they are here to present the Commission on Disabilities. Tonight they are asking the Board of Selectmen to sponsor the formation of the Commission on Disabilities. Ms. Jennings said they have been meeting for two years. Forming this would allow residents that are affected to give advice to the Board of Selectmen. Ms. Kuchta went over what the criteria would be on forming the Commission on Disabilities. Chair Ward said the Commission would be advisory. The town needs to accept provisions of this law and then approve at town meeting to change the bylaws. The members would be presented to the Town Manager and the Board of Selectmen would approve. Selectwoman LaPointe moved the Board sponsor the formation of the Commission on Disabilities. Selectwoman Blanchard seconded. Roll Call Vote: LaBrie aye, Blanchard aye, LaPointe aye, and Ward aye.

7.4. Presentation of Draft Annual Town Meeting Warrant-Bill McKinney went over the articles in the Draft Annual Town Meeting Warrant. There are thirty-one articles. He said Article 6 FY25 General Government Budget now has been grouped together. He said similar line items are now together to make it easier if money needs to be moved around in a department. Article 13 would repurpose leftover funds of the DPW roof project to be used on that building. Article 28-32 are citizen's petitions. Selectwoman LaBrie asked if the citizen's petitions are non-binding? Bill McKinney said typically they would be. We just received them today so we haven't been able to speak to Town Council yet.
