Announcements:

Chairwoman Harrington announced she had forwarded to the Commission information on different types of Historic Buildings located in Massachusetts. Mr. McCrohon announced he was recording the meeting.

Public Comments:

Mr. Haramundanis commented he believes Mr. Douglas Adams had an orchard on his property, The Adams Farm, on Hall Road. He was wondering if Commission members had any information on that? Mr. McCrohon forwarded a map that seemed to contain trees in the suspected orchard area. Mr. Haramundanis also questioned an old cart road on his property and where it lead. Ms. Sroczynski suggested reaching out to DPW as a list of discontinued roads is kept there.

Member Comments:

Ms. Y. Harrington is interested in Winchendon's Right to Farm Signs, and would like to see more of them installed around town. She would also like to see signs indicating when the Historic District is being entered. Chairwoman Harrngton suggested she reach out to DPW Director Croteau for information and pricing. Ms. Sroczynski updated the Commission on the informational sessions the town is holding regarding the prop 2 ½ Override. There is great concern among

Commission members as this would potentially affect 2 historic buildings in town. Ms. Sroczynski also mentioned work being done on a historic home, and if a permit was pulled the Commission was not notified, as they should have been. Ms. Sroczynski and Chairwoman Harrington will meet with Building Inspector Germano to ask for information. Ms. Y. Harrington would like Mr. Germano to attend a meeitng. *Motion to invite Mr. Germano to an upcoming Commission meeting Y. Harrington/Sroczynski 3-1 Approved by roll call vote.* Mr. McCrohon would like to explore the possibilities of getting grants to help owners of historic homes with repairs. Chairwoman Harrington asked Commission members to come to the meeting in May with an accomplishment.
