Civil & Environmental Consultants, Inc. (CEC) has prepared this letter on behalf of W.L. French to fulfill the monthly reporting and recordkeeping requirements at the above referenced landfill (hereby referred to as the “Site”). This submittal was prepared in accordance with Section E of the Specific Permit Conditions as described in the Permit Number X283688 (Corrective Action Design (CAD) permit approval) in order to document tonnage received in the past month and any operational problems or deficiencies encountered in the Project.

1.0 MATERIAL ACCEPTED AND REMAINING CAPACITY

The summary table below presents the tonnage received during October 2024, cumulative tonnage received to date, and remaining capacity, in tons:

Notes:

1. The permitted capacity is based on the October 20, 2023 Major Modification Permit
2. Tonnage received for October 2024 is based on scale house records for the month of October
3. Total tonnage received at the Site is based on scale house records as of October 31, 2024

As presented in the summary above, 34,569.54 tons (~18,194.49 cubic yards) were received by the facility in October 2024 which results in 269,176.22 tons (~141,671.69 cubic yards) remaining.

2.0 OPERATIONAL MODIFICATIONS TO DATE

W.L. French began to import approved soils for shaping and grading at the Site on January 19, 2021 in accordance with the CAD permit approval issued on September 23, 2020.

Following the detection of groundwater at a higher elevation than the bottom of the north stormwater basin (as designed in the initial CAD permit application), a Major Permit Modification (BWP SW 11) was prepared and submitted to MassDEP on September 6, 2022, which presented details of the stormwater redesign. The basin design was approved for an amended Order of Conditions by the Winchendon Conservation Commission at a public hearing on June 9, 2022.

The MassDEP issued a BWP SW22 Minor Modification approval on May 5, 2023, which authorized the acceptance of an additional 65,000 cubic yards, or 123,500 tons, of grading and shaping material at the Landfill in order to achieve the final approved grades.

In October 2022, test pits were performed to further define the extents of landfilled waste at the site. A proposed limit of final cap (modified based on the re-defined limit of waste) was presented to the MassDEP as part of the “Test Pit Summary Report” submitted on November 15, 2022 (Auth. # SW45-0000182). CEC submitted a major permit modification application in May 2023 which incorporated the modified limit of final cap and presented modifications to the grading and stormwater management system from the permitted Corrective Action Design. The MassDEP issued the BWP SW 11AC – Major Modification permit approval (Modifications to Corrective Action Design Permit #X283688 - Authorization No. SW11AC-0000030) on October 20, 2023, which authorized the facility to accept a total of 1,434,500 tons (755,000 cubic yards) of grading and shaping materials to achieve the modified final grades presented in the application.

3.0 OPERATIONAL NOTIFICATIONS

During the reporting period, in-place waste materials (primarily concrete and brick) were excavated from the western slope of the landfill to achieve the permitted subgrade elevations and were relocated within the permitted waste footprint. In accordance with Section IV(J) of the CAD permit, exposed waste materials were covered with a minimum 6-inches of cover soil at the end of each working day. The MassDEP was notified of these activities prior to the work commencing and upon completion of the waste relocation.


