Civil & Environmental Consultants, Inc. (CEC) has prepared this letter on behalf of W.L. French to fulfill the monthly reporting and recordkeeping requirements at the above referenced landfill (hereby referred to as the “Site”). This submittal was prepared in accordance with Section E of the Specific Permit Conditions as described in the Permit Number X283688 (Corrective Action Design (CAD) permit approval) in order to document tonnage received in the past month and any operational problems or deficiencies encountered in the Project.

1.0 MATERIAL ACCEPTED AND REMAINING CAPACITY

The summary table below presents the tonnage received during March 2024, cumulative tonnage received to date, and remaining capacity, in tons:

Notes:

1. The permitted capacity is based on the October 20, 2023 Major Modification Permit
2. Tonnage received for March 2024 is based on scale house records for the month of March
3. Total tonnage received at the Site is based on scale house records as of March 31, 2024

As presented in the summary above, 18,467.90 tons (~9,719.95 cubic yards) were received by the facility in March 2024 which results in 406,563.98 tons (~213,981.04 cubic yards) remaining.

2.0 OPERATIONAL MODIFICATIONS TO DATE

W.L. French began to import approved soils for shaping and grading at the Site on January 19, 2021 in accordance with the CAD permit approval issued on September 23, 2020.

Following the detection of groundwater at a higher elevation than the bottom of the north stormwater basin (as designed in the initial CAD permit application), a Major Permit Modification (BWP SW 11) was prepared and submitted to MassDEP on September 6, 2022, which presented details of the stormwater redesign. The basin design was approved for an amended Order of Conditions by the Winchendon Conservation Commission at a public hearing on June 9, 2022.

The MassDEP issued a BWP SW22 Minor Modification approval on May 5, 2023, which authorized the acceptance of an additional 65,000 cubic yards, or 123,500 tons, of grading and shaping material at the Landfill in order to achieve the final approved grades.

In October 2022, test pits were performed to further define the extents of landfilled waste at the site. A proposed limit of final cap (modified based on the re-defined limit of waste) was presented to the MassDEP as part of the “Test Pit Summary Report” submitted on November 15, 2022 (Auth. # SW45-0000182). CEC submitted a major permit modification application in May 2023 which incorporated the modified limit of final cap and presented modifications to the grading and stormwater management system from the permitted Corrective Action Design. The MassDEP issued the BWP SW 11AC – Major Modification permit approval (Modifications to Corrective Action Design Permit #X283688 - Authorization No. SW11AC-0000030) on October 20, 2023, which authorized the facility to accept a total of 1,434,500 tons (755,000 cubic yards) of grading and shaping materials to achieve the modified final grades presented in the application.

3.0 OPERATIONAL DEFICIENCIES IN THE REPORTING PERIOD

On March 15, 2024, the MassDEP issued a Notice of Noncompliance (NON) to 580 River Street, LLC for observed noncompliant conditions at the site. WL French has since taken actions to address the observed conditions, as described below, and the MassDEP subsequently issued a letter on March 29, 2024 stating that the facility has successfully complied with the conditions stated in the NON.

The first condition in the NON pertained to the groundwater monitoring wells at the site. The MassDEP observed that the wells MW-3 and MW-4 were not secured with locking caps to prevent tampering or vandalism. No signs of tampering or vandalism to the wells have been observed, and WL French has since installed locks on these wells.

The second and third conditions of the NON pertained to dust control measures at the site. The MassDEP noted that WL French failed to notify the MassDEP within 24 hours of a failure to the wheel wash station pump that occurred on February 23, 2024. WL French has since provided the MassDEP a Dust Mitigation Plan for the landfill closure project and implemented a daily log for use of the wheel wash station, both of which are attached to this submittal. As noted in the Dust Mitigation Plan, outbound truck traffic will exit through the wheel wash station when the daily and overnight ambient temperature is above 32 degrees Fahrenheit (i.e. when freezing conditions would not otherwise inhibit use of the wheel wash).

As described above, WL French has taken actions to address the conditions of the NON and the MassDEP has since found the facility to be in compliance with those conditions.

This plan has been developed by W. L. French Excavating Corporation to prevent fugitive dust emissions generated from Site Operations during capping of the Former Mabardy Landfill located at 580 River Street, Winchendon, MA.

Site Activity	Dust Control Measures
Inbound Truck Traffic	<ul style="list-style-type: none">--Minimum daily street sweeping and increased frequency when a high volume of trucks is scheduled.-Observe local speed limits (25 mph) and onsite haul road limits (5 mph).-Water truck sprayed on haul roads during dry/windy (>20 mph avg wind speed) conditions.-Keep loads tarped until offloading occurs.
Outbound Truck Traffic	<ul style="list-style-type: none">-Trucks must exit through wheel wash when the daily and overnight ambient temperature is above 32 degrees Fahrenheit.-Minimum daily street sweeping and increased frequency when a high volume of trucks is scheduled, or wheel wash is not in operation due to temperature.- Observe local speed limits (25 mph) and onsite haul road limits (5 MPH).Water truck sprayed on haul roads during dry/windy (>20 mph avg wind speed) conditions.-Keep loads tarped if loaded.
Active Capping Area of the Landfill	<ul style="list-style-type: none">-Water truck sprayed on haul roads during dry/windy (>20 mph avg wind speed) conditions.-Water truck utilized to prevent dust on non-vegetated plateau areas during dry or windy conditions (>20 mph avg wind speed) on dry soil being tipped from trucks and dry soil being spread and/or compacted.-Minimize disturbances that can produce dust.-Keep trucks out of muddy areas to the extent possible.-Vegitate inactive fill areas.- Utilize tracking pads prior to trucks exiting landfill footprint.

Active Landfill Capping Area of the Landfill

W.L. French will install a weather station at the scale house, which includes an anemometer to monitor wind speeds at the landfill. When average wind speeds are greater than 20 mph, as measured at the weather station located at the scale house, the Site shall ensure the water truck cannons are actively dispersing water on dry soil being tipped from trucks and on dry soil being spread and/or compacted to mitigate dust emissions. The water truck(s) will be loaded from the quarry pond or the onsite water well.

Temporary vegetative cover materials shall be utilized whenever practical in inactive or elevated areas to mitigate dust generation and counter erosion caused by wind and water, prior to final cap placement.

Haul Roads

A water truck shall be utilized to ensure the haul roads will be kept damp without causing excessive ponding or runoff beyond the site boundaries. Note that the daily temperature must be above freezing when loading water trucks or applying water to the haul roads. If the ambient daily temperature is below 32 degrees Fahrenheit and the average wind speed is >20 mph, additional dust control measures, such as calcium, may be used as needed.

Wheel Wash Station

All trucks exiting the landfill shall utilize the wheel wash station to ensure that soil is not tracked offsite. The wheel wash station shall be in operation when the daily and overnight ambient temperature is above 32° Fahrenheit. When the ambient temperature is below 32° Fahrenheit, W. L. French shall implement alternative measures approved by MassDEP.

Street Sweeping

W. L. French shall ensure that street sweeping occurs at the access road and the roadways adjacent to the landfill on all days when construction takes place at the landfill and whenever roadway conditions deem it necessary (including but not limited to stormwater or contact water runoff and windblown debris on a roadway).
