Civil & Environmental Consultants, Inc. (CEC) presents this letter to fulfill the monthly reporting and recordkeeping requirements at the above referenced landfill (hereby referred to as the “Site”). This submittal was prepared in accordance with Section E of the Specific Permit Conditions as described in the Permit Number X283688 (CAD permit approval) in order to document tonnage received in the past month and any operational problems or deficiencies encountered in the Project.

1.0 MATERIAL ACCEPTED

W.L. French began to import approved soils for shaping and grading at the Site on January 19, 2021 in accordance with the CAD permit approval issued on September 23, 2020. A summary table showing the tonnage of material accepted at the Landfill over the previous month and cumulative yardage and tonnage of material accepted is provided with this letter. Following the approval of the May 5, 2023, BWP SW 22 *Minor Modification of an Existing Landfill*, A total of 912,000 tons are permitted for the facility. As presented in the attached summary, 16,433.86 tons (8,649.40 cubic yards) were received by the facility in April 2023 which results in 135,952.19 tons (71,553.78 cubic yards) remaining.

2.0 OPERATIONAL MODIFICATIONS

During the initial test pitting within the northern permitted stormwater basin footprint, groundwater elevations were detected at higher elevations than the bottom elevation of the permitted basin. Therefore, a stormwater basin redesign was required to allow the stormwater management system to function as originally intended. A temporary basin was installed in the same general vicinity and a permanent stormwater redesign was prepared and submitted to

MassDEP under a Major Permit Modification (BWP SW 11) on September 6, 2022. The permanent stormwater basin design was approved for an amended Order of Conditions by the Winchendon Conservation Commission at a public hearing on June 9, 2022.

A Test Pit Summary Report was issued to MassDEP on November 15, 2022 that summarized the results of the test pit investigation performed by CEC personnel on October 17th and 19th, 2022 (Auth. # SW45-0000182). Observations of the test pit investigation were included in the Test Pit Summary Report that provided a 'Proposed Limit of Final Cap' and redesigned the limit of waste based on the observations of the test pit investigation.

In April 2023, CEC prepared and applied for a BWP SW22 *Minor Modification of an Existing Landfill* that detailed proposed modifications to the previously permitted and approved final closure conditions. The BWP SW22 Minor Modification was approved with a Permit Issuance Date of May 5, 2023. This approved modification authorized an additional 65,000 cubic yards, or 123,500 tons, of grading and shaping material at the Landfill in order to achieve the final approved grades.

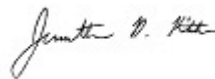
