

Winchendon Landfill Site Observation – February 27, 2023

On February 27, 2023, Aaron Sabbs from Tighe & Bond visited the Winchendon Landfill (hereby referred to as the "Site") to monitor the grading and shaping activities of the Landfill Closure Project. The Site, which is located at 580 River Street, is the former Mabardy Landfill. It is owned and operated by W.L. French Corporation (Operator) as the Winchendon Landfill. As part of the Landfill Closure Project, the Massachusetts Department of Environmental Protection (MassDEP) has permitted the acceptance of up to 415,000 cubic yards of COMM 97-001 material as defined by MassDEP Policy. In accordance with Condition 13 of the Landfill Closure Agreement between the Town and the Operator, the Site was reviewed for compliance with the following documents:

- Corrective Action Design permit approval issued on September 23, 2020 and Corrective Action Design Plans prepared by Langdon Environmental, LLC, dated June 2019 and revised October 2019.
- Initial Operations Plan, by Langdon Environmental, LLC, dated January 2021, revised to include temporary rip rap settling area.

Landfill Operations

General landfill operations appeared to comply with best practices and the Corrective Action Design. While on site, material was placed and spread by bulldozer in the general area of Section B-B of Sheet C-5 of the Corrective Action Design, within the limits designated for initial placement. This area has been graded and gravel has been placed to allow truck access as the elevation in this area increases. Material has been placed over the existing access road on the east side of the site to expand the fill footprint to its proposed limits.

The Operator maintains plows and salt spreaders on site to maintain the access roads during winter weather.

Stormwater and Erosion

Stormwater conveyances have been constructed per the Initial Operations Plan as revised to include a temporary rip rap settling area. This plan was submitted to MassDEP under a Major Permit Modification (BWP SQ 11). A swale, including check dams, has been constructed from the temporary stormwater basin to the temporary settling area. Overflow from the temporary stormwater basin runs to the settling area with a PVC drainage pipe running beneath the access road. The swale from the northern section of the site to the temporary stormwater basin has not yet been constructed.

It appears that fill has been placed in the swale to allow construction equipment to cross it. The fill is preventing water from flowing through the swale to the settling area. The PVC drainage pipe was also previously broken when additional rip rap was placed and has not been repaired.

Hydroseed was applied to the landfill's slopes in late fall. However, the seed does not appear to have germinated and recent rainfall has caused erosion throughout the slopes, including large gullies in some locations. Rainwater has accumulated at the base of the southwestern slope, with a large amount of standing water at the erosion control at the perimeter of the site. Runoff from the eastern slope has also caused a large buildup of water on the temporary access road, rendering it impassible. At the time of the site visit, the slopes were largely covered with snow and the standing water at the base of the slopes was frozen.

These stormwater issues appear to have gotten worse in the recent past and remain unchanged since the previous visit since. The late season hydroseed did not germinate and the slopes have eroded. We recommend that remedial action be taken to provide temporary stabilization measures on the slope and maintain the swales and all BMPs at the toe of the slope to remove the standing water and to ensure that the silt and sediment does not travel beyond the limit of the project. While we have observed and noted these issues, Tighe & Bond is not acting as the Stormwater Pollution Prevention Plan (SWPPP) inspector on site.

Material Accepted

Tighe & Bond reviewed the attached Net Daily Summary Report received for the month of February, which details the total tonnage and number of loads of material received by the facility. As indicated in the attached Table 1, a total of 20,013.49 tons of material was received in February, which results in 52,133.64 tons remaining of the total 788,500 tons permitted. Based on a utilization factor of 1.9 tons per cubic yard of soil, the total volume received in February was 10,533.42 cubic yards, which results in 27,438.76 cubic yards remaining. This represents about 7% of the total permitted volume remaining.

The DEP permit limits the number of loads received to 64 per day without special Town permission. There were no days in February in which the number of loads received was greater than 64.
