There being a quorum present, the meeting was called to order at 6:00PM.

### Chair Update

Pledge

Chairman Kent said the MDPH viral positivity rate for Winchendon is 5.09%. On September 9th it was 6.4%, September 16th 6.24% and September 23rd it was 4.99%. One thousand one hundred and nineteen molecular tests were performed in the last fourteen days.

Chairman Kent said the Athol Board of Health has recommended not to travel to Athol because of the high rate of 8.13%.

Chairman Kent said in Worcester County 71% of the population 12 years and up are vaccinated as of September 30th. 74% of Massachusetts residents have at least one dose.

Chairman Kent said speaking as the chair and not for the entire Board he asked if unvaccinated to consider getting vaccinated.

Chairman Kent said this has been approved previously for a three-bedroom home. It is now before the Board as a two-bedroom home.

Corey Wilson said they are using the existing wells system which stays basically in the same place. The existing well location is eighty feet from the septic which is why they requested a 20-foot variance. Jim Abare recommended testing on the well. Lionel Cloutier commented that this is normally accepted at 75 feet.

Garrett Wante asked Corey Wilson if this is the best possible design. Corey Wilson said yes there is no where else it can go. Lionel Cloutier asked how close the septic tank from the house is. Corey Wilson said it is twenty-two feet. Tina Santos asked if there are any concerns from abutters. Corey Wilson said the neighbors all want to see this done. Jim Abare said this is the best of a difficult situation. It is a small lot.

Lionel Cloutier made a motion to approve. Garrett Wante seconded the motion. After some discussion. Lionel Cloutier retracted his motion and made the following motion to approve with the well being tested for three years. Garrett Wante seconded the motion. Tina Santos read the fee has been paid of \$100 for food permit #2149. There were the following comments, the floor tile and ceiling tiles need repair/replacing and general cleaning needs to be done. James Abare said he spoke to the manager of Family Dollar who said they will put in a work order for the floor tiles and will work with the owner on the water damaged ceiling tiles. Lionel Cloutier said they had buckets in there today. Chairman Kent said they need to speak to the owner concerning the roof. Tina Santos said there was a conversation that house cleaning needs to be done on a regular basis. James Abare said he will contact the owner to discuss the roof issue. Garrett Wante commented a temporary permit should be given with the Health Agent revisiting it. James Abare said to give 90 days. Garrett Wante made a motion to approve a temporary food permit for Family Dollar for 90 days with the following stipulation: increase cleanliness in the building and have the Health Agent speak with the owner to rectify the other issues.
