Mr. John Deline is in attendance seeking a variance for a septic system installation at 389 Elmwood Road. He explained this is a 11,000 square foot lot. The only location for the system is in the back of the lot, and the soils are tough. He drew the plans may times and this was the only option. The reduction of the leach area will be 1000 sq ft to 600 sq ft. This should not pose any issues as new technology equipment will be used. The ground water offset will go from 4 ft to 2 ft, and the set back from stream will reduce from 50 ft to 17 ft. No trees will be cut. There will also be no property encroachment.
