## PERMIT/LICENSE APPLICATIONS:

Special One Day Wine & Malt License for Winchendon Kiwanis Dinner Theater at The Winchendon School, 172 Ash St., to be held on Oct. 14, 2017 - Mr. Bruce Cloutier came forward on his application and apologized for the lateness of the application and thanked the Board for addressing it this evening. He explained the Club needs to raise money to support the Back Pack Program which is feeding over one hundred kids. They are planning a comedy dinner theatre at The Winchendon School who is graciously cooking a chicken dinner. The Kiwanis are looking to be able to serve wine and beer with the chicken. They are limiting the tickets to 120 at a cost of \$45.00 each. The Carriage House will be providing the TIPS certified personnel to serve that evening. The tickets can be purchased from him and from To Each His Own. He said they hired a group of actors from Amherst that provide a good, clean comedy routine between dinner courses. He noted that The Winchendon School kids and Murdock Key Club kids pack the backpacks on Fridays and thought it would be good to involve the School in this fundraiser. Parking will be provided at the hockey rink if needed. The Key Club students will direct people where to go.
