3.1 Christmas Tree Sales Permit – Byron Beauregard, 80 Old Centre – LaBrie noted they were doing this a bit backwards this evening regarding approving the Christmas Tree sale permits but that it was okay. Mr. Byron Beauregard came forward and was asked by the Chair how long he has been selling Christmas Trees. Mr. Beauregard responded for six or seven years now. Ms. Daigle said the application is complete and that there were no issues from Department Heads; the fee has been collected. Barbaro reminded Mr. Beauregard to file an application for a permit next year before he sells trees. Anderson noted the address and the hours he will be selling trees.

Barbaro moved for the applicant; Anderson seconded. By a vote of all aye, the motion carried unanimously.

Daigle asked if the Board could recess to sign the permit while they waited for the second applicant to arrive this evening.

Barbaro moved for a five minute recess; Anderson seconded. By a vote of all aye, the meeting recessed at 6:36PM.

The meeting reconvened at 6:41PM.

3.2 Christmas Tree Sales Permit - Mason's Lodge – 319 School St. – With the applicant not being present, **Anderson asked to move the permit and waive the usual fee; they are a non-profit and do an awful lot of good things in Town. Barbaro seconded.** LaBrie asked Ms. Daigle to ensure the applicant is clear they need to come in annually for a permit.
By a vote of all aye, the motion carried unanimously.


4. **NEW BUSINESS:** There was none this evening.
