Discussion on removal of 'Planning Board' from charter, reasoning is that it is not a part of the legislative branch of town government. Planning Board is to be added to article 4 section 4-3 planning board.

#### Section 3-2c

Lauren Goldberg noted appointment list is not required, except Town Manager, Town Accountant and Constables. Recommended adding "except as amended by town meeting vote.

# Article 3

#### Section 3-1c

Lauren Goldberg noted all terms for elected officials can begin later than town meeting for example July 1<sup>st</sup>.

Section 30.1-30.4

Lauren Goldberg noted that all provisions need not be enforced as state law is in place.

## Section 30.5

Lauren Goldberg has concerns regarding town's involvement in resolution dispute.


