<u>YEAR TO DATE REPORTS:</u> Chairman Kane said he met with the Town Accountant and he is trying to close out FY16. Chairman Kane said he told the Town Accountant and he is trying to get done what he needs to so the town gets the fiscal year closed on time. He asked the Town Accountant if he could have the year to date reports by September. He thought revenues look very good but has some concerns with the Enterprise Funds. Chairman Kane said Mr. Hickey told him revenues came in \$50,000 over the projections. He said this year there will be some free cash.

Chairman Kane said the Town Accountant knows what we are looking for. Jim Robichaud said he thinks we are going in the right direction. Robert Guenther said it's a different atmosphere with the Town Accountant and the School Accountant working together.

Dr. Maureen Ward said the next meeting is a joint meeting with the Board of Selectmen and School Committee. Chairman Kane said the School Committee offered to meet on September 1<sup>st</sup> at 6:30p.m. He said if you would like to see specific issues on the agenda to let him know.
