- 3. Administration of Safer Grant created problems

Mr. Sulzbach went over:

- Expectations for maintenance of existing capital items.
- The town hall building has both long and short term needs bricks falling off of the exterior, ivy growing into the building, etc
- Design work needs to be done to fully assess costs and needs
- Robinson and Broadhurst Grants
- Paving projects
- Commercial growth on Front Street
- Work needed to be done in conjunction with the Redevelopment of Central St.
- Approx. \$350,000 currently in Reserve Fund
- Cannabis should be coming on line shortly which will give a boost to revenues
- COVID funding needs to be spent by Dec approx. \$275,000 left from first round
- Applied form Round Two of American Recovery Act (\$3,259,579)
