Mr. Croteau has received complaints of loose garbage in the plaza parking lot in front of Family Dollar and Subway, as well as in the back of the Valero Gas Station/Gourmet Donuts building, where an old shack was torn down, and a lot of garbage remained. Mr. Croteau referred to Mr. Abare, who would be contacting these businesses to address the issue.

Soil Evaluation Line Item

Mr. Croteau raised the issue of a soil evaluation line item that saves local homeowner's money at the expense of the town. When the homeowners receive a variance on a soil evaluation, the town often has to outsource the soil inspection, which costs around \$150.00 per inspection. Mr. Croteau would like to see this fee reimbursed by the homeowner as a second line item. This would save the town money, by having the homeowner pay the inspection fee, and the homeowner would still save money by not needing to pay for the materials.

Mr. Croteau motioned to institute a policy change for soil testing, so the homeowner is responsible for an outside surveyor to come in for \$150.00 fee per inspection. Mr. Gauthier seconded the motion.

Open Discussion:

Animal Inspector Pay Explanation

Mr. Abare explained to the Board that the two separate Animal Inspector invoice, as listed above \$800 for 2 inspections, \$400 apiece, was due to Winchendon and Templeton sharing the costs of the animal inspector, and that, which it looks like the town of Winchendon is paying double the line item, Templeton is paying half, to the town of Winchendon, which negates overpaying on this line item.

41 Juniper St.

The Board of Health established that the property of 41 Juniper St., Winchendon, MA is now in the courts hands, and the receiver has been up a couple of times, to allow the inhabitants into the home to retrieve some belongings, as well as to re-secure the property. Mr. Croteau mentioned that the neighboring property owner had shown interest in purchasing the property, to which Mr. Abare responded that any such purchase would be taking place between that individual and the receiver. Mr. Croteau also noted that the property across the street was also being vacated. Mr. Abare stated that the property was being repaired for water damage due to a frozen pipe.

GVNA

Mr. Croteau spoke to the Winchendon Fire Department, which had just received a grant that would allow them to do clinics and possibly replace the Gardner Visiting Nurses, and may allow the town to save money, and asked that the Board look into doing so.
