### **Grease Traps:**

Chairman Cloutier asked the board about the issue of town policy and maintenance of grease traps for restaurants in the town. Mr. Croteau said that the problem was solved, and that there are new restaurants coming in to town. Mr. Abare noted that while the restaurants have not yet applied for permits, when they do, they will also be made aware of the town's grease trap policies.

## Open Discussion:

## 41 Juniper St.

Chairman Cloutier read the notice of the condemnation and need to vacate the property, within 24 hours, at 41 Juniper St. The residents of the property made note that they thought they had 48 hours from the notice to vacate, and that they need more time and money to move. Chairman Cloutier asked the residents how long the issue with the property had been going on, and the residents admitted that the issue had been going on for about a year and a half. The board explained to the residents that the notice was a judge's order, and cannot be undone by the Winchendon Board of Health. Mr. Abare noted that the receiver and the town may be able to help move the belonging in the property to where the residents will be relocating to. The residents asked if the town can help them get funds to move into a new apartment. Mr. Abare replied that the town is not responsible and cannot help with the allocation of these funds.

Mr. Croteau moved to advise the Board of Health Agent, Jim Abarre, to serve the property, based on the recommendation of the courts, with a letter of eviction due to the property being unsafe as soon as the town's lawyers approve it. The Winchendon Board of Health finds the property at 41 Juniper Street is unfit for human habitation in that the danger to life and health of the occupants is so great as a result to the violation at the property that no delay may be permitted in issuing the condemnation and order to vacate. Mr. Gauthier seconded the motion.
