OLD BUSINESS:

Updates-60 Franklin Street-Chairman Cloutier said there has been no update from the Health Agent.

41 Juniper Street-Town Counsel is trying to expedite a court date.

50 Franklin Street-Chairman Cloutier said they are waiting for an update from Mr. Gund from the Worcester DEP office.

MRPHN-Jason Moury said we are trying to join. They are currently revamping the program. They have a meeting on Wednesday. Everyone else around us has joined. We need to see what the fee structure will be.

NEW BUSINESS:

Angel Program-It is a program that helped stop opium overdoses. The Board discussed writing a letter to the Town Manager and ask him to consider putting these in the Police Chief's goals and objectives. Chairman Cloutier said he brought it up to the Town Manager and the Police Chief and they said they are very interested in the program. Jason Moury said before it is added to the Police Chief's goals he would like to see what the plan is. He said there is no doubt that it is needed. The Police Chief should have some input in this. He said it's time to reinvigorate the Opiate Task Force. He said he is not comfortable adding it to the Police Chief's goals. Edward Bond said he believes the Police Chief uses it as a guideline. He said he feels this is a better way of attacking the problem. Jason Moury said he has no problem having the Town Manager present this to the task force. This is a public health crisis. Chairman Cloutier said a letter needs to be sent to the Town Manager asking to reinstate the Opiate Task Force and have the Angel Program as an agenda item. The Board decided that they didn't need a letter the Chairman would talk to the Town Manager.

PUBLIC COMMENTS: Mr. Pratt came forward and gave the Board more information concerning the excessive dust on his road. He showed the Board some pictures, gave them some EPA information off of the Website concerning particulate matter PM-10. Chairman Cloutier said this was brought up to the DPW Director. Mr. Pratt said this is an air quality complaint. It was previously a paved road. Jason Moury said his concern is he doesn't know what the next step is if any. Mr. Pratt said he has sent samples out to be tested and when he gets the results he will inform the Board of the results. Jason Moury said paving is the Board of Selectmen issue. We want to help you and make sure the air quality if fine. He asked for this to be an agenda item for the next meeting. Chairman Cloutier said he will bring it up to the DPW Director and Mr. Hickey and show them the pictures on his behalf.

A motion was made by Edward Bond to adjourn the meeting; Diane Cosentino seconded. All aye.
