G. Corbosiero read the public hearing notice and opened the hearing.

Trevor Fletcher, Engineer with Graz Construction, introduced himself and discussed the project. The request is for approval of a reduced frontage single family lot. It was noted that the lot is not able to be subdivided in the future.

Russell Hughes of 35 Doyle Ave. voiced his concern with the project. It was noted that the required frontage for the R80 zone is 200 ft. The minimum, if requesting reduced frontage, is 50 ft.

Theresa Pfeifle of 245 Hale St. had some questions and concerns. She questioned if the lot would be able to be subdivided in the future, which the board responded no, not with the current bylaws.

A concerned resident questioned the need for the reduced frontage when there is a 90 acre parcel.

A condition was suggested to implement a 100 ft buffer from the property line. The board and T. Fletcher discussed the condition to determine the specific verbiage.

A. Phillips motioned to approve the reduced frontage lot with an added condition- 100 ft landscape buffer between the proposed construction and 35 Doyle Ave, with an exception of where the driveway will be installed, 2nd by A. Amenta.
