**6:30PM-** Vice-Chairman Scott Robillard called the Planning Board meeting to order followed by the Pledge of Allegiance to the flag of the United States of America.

**6:35 PM- Public Hearing Continued-** Happy Hollow Site Plan Modification Review- application received requesting permission to clear an additional 3.47 acres of trees leaving a wooded 50' buffer with the abutting residential properties.

An estimated 300 trees were flagged for cutting in the 3.47 acres. The proposed re-planting would be a mix of ever-greens, shrubs, and grasses.

Ms. Manugian stated that Borrego offered to give the town assurity of \$20,000 towards plants to go in the spring and fund the landscape architect separately.

Richard Aimes, an abutter of the project, expressed his disappointment with the plan. Doreen Aimes stated that since the project started, the sand storms have been worse and cause sand to blow around
