In conformity with the requirements of Section 22 of Chapter 166 of the General Laws (Ter. Ed.), you are hereby notified that a public hearing is scheduled to be held by the Board of Selectmen of the Town of Winchendon, Massachusetts, on the 14th day of September, 2020 at 6:35 p.m. upon the petition of Massachusetts Electric Company, d/b/a National Grid, requesting permission it desires to locate poles, wires, and fixtures, including the necessary sustaining and protecting fixtures, along and across the following public way.

<u>Hall Road</u>: National Grid to install I (one) SO Pole on Hall Road beginning at a point approximately 257 feet southwest of the centerline of the intersection of Spring Street and Hall Road and continuing approximately I5 feet in a north direction. Install one SO pole on Hall Road for OH service of new residential home.

Location approximately as shown on plan attached.

Wherefore it prays that after due notice and hearing as provided by law, it be granted a location for and permission to erect and maintain poles and wires, together with such sustaining and protecting fixtures as it may find necessary, said poles to be erected substantially in accordance with the plan filed herewith marked- Hall Road- Winchendon- Massachusetts.

Plan No. 29831550 dated August 17, 2020.

Also for permission to lay and maintain underground laterals, cables and wires in the above or intersecting public ways for the purpose of making connections with such poles and buildings as each of said petitioners may desire for distributing purposes.

Your petitioner agrees to reserve space for one cross-arm at a suitable point on each of said poles for the fire, police, telephone, and telegraph signal wires belonging to the municipality and used by it exclusively for municipal purposes.
