

 - School Committee review and approval of Massachusetts School Building Authority Statement of Interest applications for Accelerated Repairs on school buildings

Suggested Motion:

Having convened in an open meeting on 2/26/24, prior to the SOI submission closing date, the school committee of Winchendon, in accordance with its charter, by-laws, and ordinances, has voted to authorize the Superintendent to submit to the Massachusetts School Building Authority the Statement of Interest Form dated February 2024 for the Memorial School, Toytown School & Murdock Middle/ High School located at 32 Elmwood Rd, 175 Grove St & 3 Memorial Dr. which describes and explains the following deficiencies and the priority category(s) for which an application may be submitted to the Massachusetts School Building Authority in the future. The following deficiencies are as follows: roof replacement, window replacement & door replacement and hereby further specifically acknowledges that by submitting this Statement of Interest Form, the Massachusetts School Building Authority in no way guarantees the acceptance or the approval of an application, the awarding of a grant or any other funding commitment from the Massachusetts School Building Authority, or commits the Town of Winchendon or Winchendon Public Schools to filing an application for funding with the Massachusetts School Building Authority.
