7:00pm - PUBLIC HEARING CONTINUATION - Comprehensive Permit application from the Montachusett Veterans' Outreach Center for redevelopment of the former Poland and Streeter Schools on Oak Street and Murdock Avenue (Assessors Map-Lot 5B2-117 & 118). Said redevelopment to create 44 units of housing for veterans and related site work and improvements. Said property is located in a R10 – Neighborhood Residential District.

Public hearing must close by 10/25/2021 with decision rendered by 12/3/2021

7:10pm – **PUBLIC HEARING** – Special Permit for use allowing a 'Go-cart/off road motorcycle racetrack' submitted by property owner Krasun Industries of 841 Rte 32 in Franklin, CT 06254 identified as Winchendon Assessors Map 9 Parcel 38 or 783 Spring Street. Said property is located in an 'I – Industrial district'

Discussion of 75 First Street – Special permits to raze and rebuilt and to alter a non-conforming parcel were granted in February of 2019. The applicants, Karen & Travis Drudi, have changed the plan and want to add on to the existing structure. Discussion and guidance as to need to formally amend permit to alter a non-conforming lot. Hearing was improperly advertised but can be scheduled next month.
