



This application is for a Change of Officers and Directors and Change of Manager for Tamilin Corp, doing business as Carriage House Restaurant in Winchendon. Investigator Bolcome communicated with the applicant, Joseph Furlong, while reviewing the application.

Furlong indicated that he was taking over as President for the restaurant and was advised to file a Change of Officers and Directors. It was later discovered that Tamilin Corp had been sold to Furlong, and there was a complete transfer of stock from the prior owners.

The applicant should reapply for a Change of Manager and an Issuance/Transfer of Stock/New Stockholder to include the statutory obligation of an advertisement. Any Purchase and Sale Agreements and related documentation should be included in the application.
