
PROPOSED UNDERGROUND UTILITIES



- 1. THE PURPOSE OF THIS PLAN IS TO DEPICT THE WORK RELATED TO THE PROPOSED DRIVEWAY AND DWELLING FOR MAP-1 LOT-1 & 2 LAKE MONOMONAC IN WINCHENDON MASSACHUSETTS. (OFF DOLLY LANE RINDGE, NH)
- LOTS LOCATED IN THE R-40 (RURAL SUBURBAN RESIDENTIAL) ZONING DISTRICT: FRONT SETBACK: 40' SIDE SETBACK: 25'
- 3. SILTFENCE IS TO BE INSTALLED PRIOR TO THE START OF ANY CONSTRUCTION AND SHALL BE INSTALLED AS SHOWN ON THIS PLAN TO PREVENT THE MIGRATION OF ANY SOILS INTO THE LAKE SIDE OF THE FENCING.
- 4. THE CONTRACTOR IS RESPONSIBLE FOR THE MAINTENANCE AND REPAIR OF ALL EROSION CONTROL DEVICES ON-SITE. ALL EROSION CONTROL DEVICES SHALL BE REGULARLY INSPECTED AND REPAIRED/ ADJUSTED.
- 5. AN ORDER OF CONDITIONS MUST BE OBTAINED FROM THE CONSERVATION COMMISSION FOR THE WORK SHOWN HEREON.
- 6. THE SILT FENCING IS THE PROPOSED LIMIT-OF-WORK. NO CLEARING, CUTTING, DIGGING, MATERIAL STORAGE, EQUIPMENT STORAGE, ETC. MAY OCCUR ON THE LAKE SIDE OF THE FENCING.
