Ed.), you are hereby notified that a public hearing is scheduled to be held by the Board of Selectmen of the Town of Winchendon, Massachusetts, on the **8th day of March at 6:30 p.m.** upon the petition of Massachusetts Electric Company, d/b/a National Grid, and Verizon New England, Inc., requesting permission it desires to locate poles, wires, and fixtures, including the necessary sustaining and protecting fixtures, along and across the following public way.

High Street: National Grid to install one (1) JO Pole on High Street beginning at a point approximately 340 feet southwest of the centerline of the intersection of High Street and Old Center and continuing approximately 20 feet in a west direction. Install P63-1 in public way on High Street.

Location approximately as shown on plan attached.



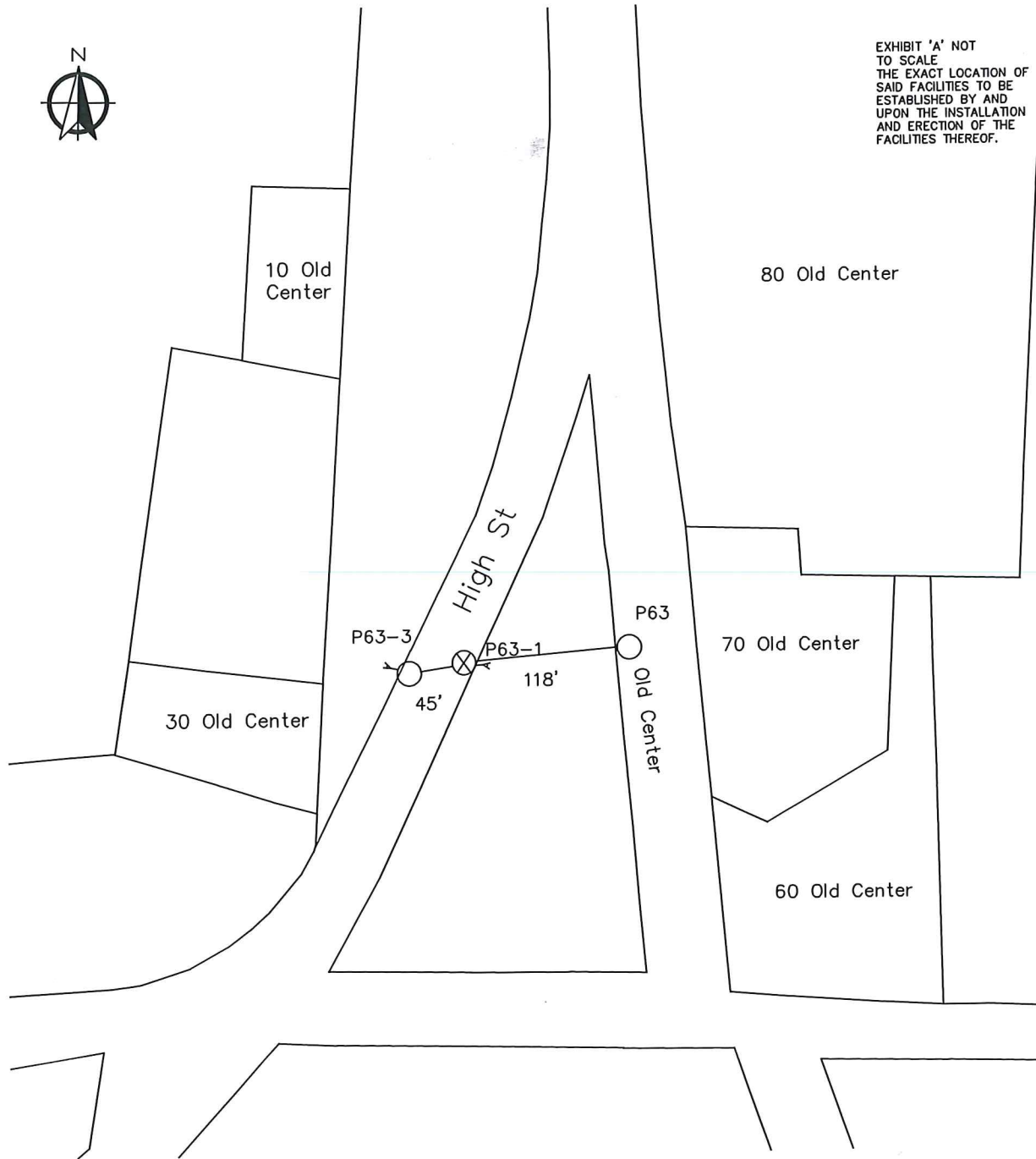
