

FY23 APPOINTMENTS:

1. FY23 Montachusett Joint Transportation Committee (MJTC) - There are two positions the Town holds on this committee. One is filled by the Planning Board and is currently held by Guy Corbosiero; the other is filled by the Board of Selectmen, which is currently held by DPW Director, Brian Croteau. MJTC is a subcommittee of the Montachusett Regional Planning Commission (MRPC) that provides public input to the transportation planning process in the Montachusett Region. The MJTC plays an important role in the development of the Transportation Improvement Program (TIP). Appointees are at the discretion of the Board and do not have to be a Board member or employee. Mr. Croteau is willing to continue to serve in this role. Brad Harris, Transportation Project Director, emailed the Board pertaining to this appointment. It has been placed in the Dropbox.

MJTC meets the second Wednesday of each month at 2:30 p.m. and are currently held remotely through GoToMeetings.

2. Montachusett Metropolitan Planning Organization (MPO) Appointment of Subregion 1 Representative – This seat is a three year seat and currently Barbara Anderson is the appointed Sub-region 1 Representative with Tracy Murphy as the designee. Barbara’s term is still in affect (see Brad Harris’s recent email in your Dropbox along with information about the organization.) The Board needs to select a new Designee to replace Tracy. DPW Director, Brian Croteau, has been attending the meetings and is willing to serve in this role if you so choose. The committee meets the third Wednesday of the month at 1:00pm via GoToMeetings. The following motion is offered.

3. FY23 Montachusett Regional Planning Commission (MRPC) Alternate – MRPC is an independent subdivision of the Commonwealth of Massachusetts, a public agency which consists of representatives of each of its 22 member municipalities and employs a staff to perform planning functions for cities and towns which comprise our district. Each municipality appoints representatives to serve on the Commission. The Planning Board appoints the Member and the Selectmen appoints the Alternate-Member. Each municipality has one vote at the monthly board meeting on matters that arise. Rick Ward is your current alternate member and may be willing to continue in this role.

“Alternate-Members from Municipalities. There may be a designee, who may or may not be a planning board member, appointed annually by the Selectmen in a town, who may attend meetings of the Commission and who shall assume the rights and duties of the Planning Board member in his/her absence.”

The Commission meets once a month on the first Thursday of every month at 7:00p.m. remotely via GoToMeetings.

4. FY23 Montachusett Regional Transit Authority Advisory Board (MART) – Members of the MART Advisory Board is composed of the Chief Elected Official of each of the member communities of MART, or a representative of the Chief Elected Official who has been appointed as a designee. Your current representative is Town Manager Justin Sultzbach.

MART meets on a quarterly basis. Meetings typically begin at 10:30a.m. currently through Remote Zoom Meeting.
