3. Project Updates-

a. <u>Opiate Abuse Crisis Task Force-</u> As a direct result of the significant uptick in cases involving opiate abuse in town, I have established a crisis task force to work toward identifying support options and solutions to this critical matter. The group is comprised of representatives from local and regional Health, Human Services, Law Enforcement, EMS and Administration.

Just today the Police Chief and Lieutenant attended a forum on the subject (information enclosed).

TO date, the group has reached out to the Mass Opioid Abuse Prevention Coalition (MOAPC) to engage and interface with their ongoing efforts. (see attached)

Additionally, we have entered into discussion with the makers of the documentary "The Hungry Heart" to work toward hosting a regional public screening of the movie here in town hall. (see information attached)

A friend recently wrote something about opiate abuse that grabbed my attention-

"These aren't 'dirty dope friends or junkies,' they are someone's daughters, sons, brothers, sisters, husbands, wives caught in the web of addiction. Save a life and show love and compassion."

It is far too easy to become desensitized to issues in today's culture and we all have an obligation to not do so in matters of critical import. Opiate abuse is one such matter.

The Task Force will be updating you as we progress.

b. <u>Police Station Project-</u> Owner's Project Manager (OPM)- CDR Maguire is ready to begin as we executed contracts last week.
